Description

The Heath occupies a prominent and elevated position on Penmaenmawr Road and comprises a large detached four storey building. The property is located within a self-contained 1.72 acre site with a large tarmac car park for 57 spaces to the rear. The upper floors have coastal views out to Anglesey and Llandudno.

The property opened in 1897 as The Heath Memorial Convalescent Home and has more recently been used as offices by Conwy County Borough Council's Highways Department. The property is not listed but falls in a Conservation Area.

The property is stone wall construction under a pitched slate covered roof.







Current Layout












Potential Residential Layout Subject to Planning Permission






Location
